<p><b>IMPORTANT:</b> Pleading Guilty to any of the Criminal Traffic offenses listed above will result in a conviction of a Class 3 Misdemeanor on your public record.</p>
<p><b>** If your citation alleges any charge(s) designated as criminal, criminal traffic or arises from an accident involving serious injury or death, you must appear in court in person on the "appearance date" listed on the bottom portion of your citation. **</b></p>
<p><b>MINORS:</b> If you are a minor at the time of your scheduled appearance date, you <b>MUST</b> bring a parent or guardian with you.</p>

**IMPORTANT NOTE:** You must complete the class 7 days prior to your "appearance date".

**ATTENTION:** Minors **MUST** appear with a parent or legal guardian on your scheduled appearance date. Minors cannot attend defensive driving school without a court appearance.
