

IMPORTANT NOTICE

If you have received a citation for violating 28-645A3A or 28-647.1 (also 28-8558 which resulted in an accident causing serious physical injury) or if you are under the age of 18 and have been cited for a 1st offense moving violation, you may be eligible to attend Defensive Driving School (DDS) and have the violation dismissed. If you choose not to attend DDS or are not eligible and are found responsible for the violation, you will be assigned by the MVD to attend a Traffic Survival School when MVD receives notice of the violation.

Failure to follow one of the procedures listed below on or before your appearance date will result in one or more of the following:

1. Default judgment and civil sanction
2. Suspension of your driving privilege
3. Collection referral, placement on your credit record and addition of a collection fee
4. Income Tax interception

A \$20 time-payment fee will be added to payments not RECEIVED in our office on or before the appearance date.

IF YOU WISH A HEARING SET:

You must come to the Prescott Justice/City Court, Room 103, Yavapai County Courthouse, Prescott, AZ on or before

Your appearance date listed on your citation. YOUR CASE WILL BE SET FOR HEARING AT A LATER DATE. You are giving up the option of attending DDS and having your charge dismissed.

Request for reasonable accommodation for persons with disabilities must be made to the Court by parties at least three (3) working days in advance of the scheduled court proceeding.

IF YOU WISH TO PAY YOUR CIVIL SANCTION:

1. Determine amount of sanction
2. Complete the PAYMENT INFORMATION AND METHOD OF PAYMENT section
3. Mail your copy of the citation with your payment to the Court so that it is RECEIVED in our office on or before your appearance date
4. Sign the following statement

"I hereby waive my right to a hearing, enter a plea of responsible for the violation described on the complaint, and consent to judgment imposing the prescribed civil sanction. I do not wish to attend DDS (if qualified on applicable violations)."

INSUFFICIENT FUNDS CHECKS will result in default judgment, suspension of your driving privilege, collection agency referral, placement on your credit record and addition of NSF and collection fees.

DEFENSIVE DRIVING SCHOOL (DDS) DIVERSION OPTION IN LIEU OF PAYING YOUR CITATION:

IF YOU ATTEND THE DDS, YOUR VIOLATION AND FINE WILL BE DISMISSED AND WILL NOT GO ON YOUR DRIVING RECORD. **YOU MAY ONLY ATTEND FOR ONE MOVING VIOLATION PER CITATION. YOU ARE ELIGIBLE TO ATTEND DDS IF:**

1. Your traffic violation is marked by an asterisk (*) on the bond schedule and did not result in death or serious injury.
2. You have NO attendance at any DDS for complaint dismissal in the last 12 months from the date of the last violation for which attendance at DDS was authorized.

REGISTER AND COMPLETE DDS AT LEAST SEVEN (7) DAYS PRIOR TO YOUR COURT DATE.
