**THE COURT FINDS:**

**4. ACCEPTANCE OF LETTERS:** The  **Limited**  **General** Guardian(s) shall sign the Acceptance of Appointment under oath, and file the Acceptance with the Clerk of the Court, Probate Registrar.

**5. ANNUAL REPORT OF GUARDIAN(s):** The Guardian(s) shall report to the Court on the status of the Adult and the need to continue the  **Limited**  **General** guardianship at least annually on the anniversary of appointment as required by A.R.S. §14-5315, by filing the required form with the Clerk of the Court.

**6. DRIVER'S LICENSE:** The right of the ward, \_\_\_\_\_ to retain or obtain a driver license  **is**  **is not** suspended by the appointment of a Guardian.

- 7. **VOTING RIGHTS:** The right of the ward, \_\_\_\_\_

- 8. **CHANGE OF ADDRESS:** The Guardian(s) shall **immediately** notify the Court in writing of any

any costs associated with the failure to do so.
- 9. **OTHER DUTIES UNDER THE LAW:** The duties of the Guardian(s) as required by Arizona law  
(A.R.S. §14-5209) and as set forth in this Order and the Order to Guardian(s) shall continue until the  
Guardian(s) is/are discharged from these duties by order of this Court.

**IT IS FURTHER ORDERED:** Setting this matter for internal review within \_\_\_\_\_ days to determine
