**CIVIL TRAFFIC:** You must fill out the form on the other side of this sheet and return it in person or by mail before the appearance date on the bottom of your ticket. Failure to return this completed form before your appearance date will result in a SUSPENSION OF YOUR DRIVER'S LICENSE.

#### \*PLEASE NOTE\*

The appearance date is NOT a hearing date. It is the <u>last day</u> you have to contact the court regarding your ticket to prevent the possible penalties: issuance of a warrant for your arrest, entry of a default judgment, a driver license suspension, and additional monetary penalties including a \$20.00 late fee pursuant to A.R.S. §12-116.

By pleading responsible and paying the fine your license, registration, and plates will be suspended by MVD for 3, 6, or 12 months depending on your prior convictions.

## THE FULL FINE AMOUNT AND SUSPENSION WILL NOT BE IMPOSED IF YOU CARRY OUT THE FOLLOWING INSTRUCTIONS:

#### If you had insurance on the date of the offense:

Provide the court with proof of valid insurance by your appearance date and the charge will be dismissed.

## If you did NOT have insurance on the day of the offense:

You may obtain <u>6 months</u> of insurance, provide proof of your new insurance and a copy of your MVD record\* which has no prior convictions for ARS 28-4135 within the past 24 months or no more than one conviction within the past 36 months, and the fine will be reduced to \$130.00.

## Option #3 Defensive Driving School (DDS)

You may be eligible to have a <u>civil</u> traffic moving violation dismissed by attending Defensive Driving School (DDS) from an ARIZONA Certified School. You are not eligible if you have attended DDS within one (1) year. Attending DDS can dismiss only <u>ONE</u> violation. Completion of DDS means you will not pay the fine to the court and you will not have points assessed on your license.

To attend DDS for dismissal of a violation:

1. Go to www.azdrive.com or call 1(888)334-5565 for a list of certified schools.

On www.azdrive.com:

- 1. Read all the information, then ENTER COURT DATE at bottom of page.
- 3. Choose from the list of certified schools.
- 2. You must pay for, enroll, and complete a <u>DISMISSAL class</u> at least <u>seven (7) days</u> <u>before</u> the appearance date on the bottom of your ticket.
