## CAREFULLY READ ALL INSTRUCTIONS TO TAKE CARE OF YOUR TICKET

Your ticket may include up to 5 violations labeled A through E. The violations may be criminal or civil.

### CRIMINAL AND CRIMINAL TRAFFIC:

You must call the Court for instructions by the appearance date on the bottom of your ticket. Failure to contact the Court may result in a **WARRANT** for your arrest.

**CIVIL TRAFFIC:** You must fill out the form on the other side of this sheet and return it in person, by email or by mail before the appearance date on the bottom of your ticket. Failure to return this completed form before your appearance date will result in a **SUSPENSION OF YOUR DRIVER'S LICENSE.**

### \*PLEASE NOTE\*

The appearance date is **NOT** a hearing date. It is the last day you have to contact the court regarding your ticket to prevent the possible penalties: issuance of a warrant for your arrest, entry of a default judgment, a driver license suspension, and additional monetary penalties including a \$20.00 late fee pursuant to A.R.S. §12-116.

## YOU MUST CALL THE COURT FOR INSTRUCTIONS

### DRIVING WITHOUT INSURANCE

#### ARS 28-4135 No Insurance

#### Mandatory Fine and MVD Suspension

1<sup>st</sup> offense: \$938 fine, 3 month suspension

2<sup>nd</sup> offense: \$1,383 fine, 6 month suspension

3<sup>rd</sup> offense: \$1,828 fine, 1 year suspension

By pleading responsible and paying the fine your license, registration, and plates will be suspended by MVD for 3, 6, or 12 months depending on your prior convictions.

THE FULL FINE AMOUNT AND SUSPENSION WILL NOT BE IMPOSED IF YOU CARRY OUT THE FOLLOWING INSTRUCTIONS:

**If you had insurance on the date of the offense:** Provide the court with proof of valid insurance by your appearance date and the charge will be dismissed.

**If you did NOT have insurance on the day of the offense:**

You may obtain 6 months of insurance, provide proof of your new insurance and a copy of your MVD record\* which has no prior convictions for ARS 28-4135 within the past 24 months or no more than one conviction within the past 36 months, and the fine will be reduced to \$130.00.

**Option #3**

**Defensive Driving School (DDS)**

You may be eligible to have a civil traffic moving violation dismissed by attending Defensive Driving School (DDS) from an ARIZONA Certified School. You are not eligible if you have attended DDS within one (1) year. Attending DDS can dismiss only ONE violation. Completion of DDS means you will not pay the fine to the court and you will not have points assessed on your license.

**\*You may attend defensive driving school online.\***

To attend DDS for dismissal of a violation:

**1. Go to [www.azdrive.com](http://www.azdrive.com) or call (888)334-5565 for a list of certified schools.**

On [www.azdrive.com](http://www.azdrive.com):

1. Read all the information, then ENTER COURT DATE at bottom of page.
3. Choose from the list of certified schools.

**2. You must pay for, enroll, and complete a DISMISSAL class at least **eight (8) days before** the appearance date on the bottom of your ticket.**

**IF YOU HOLD A COMMERCIAL DRIVER'S LICENSE YOU ARE NOT ELIGIBLE TO ATTEND DDS \*UNLESS DRIVING A NON-COMMERCIAL VEHICLE AT THE TIME CITATION RECEIVED (Eff. 9/1/19)**

If you are required to pay fines, penalties, fees or other financial obligations as a result of the judgment of this court and **you are unable to pay** bring this information to the attention of court staff or the Judge because payments over time or other alternatives may be available. Do not ignore your responsibility to pay, as this may result in additional penalties and costs to you.
